
1. Describe your personal and educational background, as well as in what areas you have an expertise that will aid the NLA School Board in its missions of proper governance, financial oversight, and academic growth.


1. Describe your personal and educational background, as well as in what areas you have an expertise that will aid the NLA School Board in its missions of proper governance, financial oversight, and academic growth.
